# What is this product?

## TYPE OF PRODUCT

The product is a Sub-Fund of BIL Invest, an Undertaking for Collective Investment in Transferable Securities (UCITS) incorporated as a variable capital investment company (SICAV) under the laws of Luxembourg.

## TERM

The Fund is established for an unlimited duration. However, the Board of Directors of the Fund may decide to close the Fund under certain circumstances.

## OBJECTIVES

## Principal assets traded

Bonds and other debt securities denominated in USD issued or guaranteed by governments, international and supranational organisations and public entities, with a minimum rating of BBB- /Baa3 (or equivalent) by one of the rating agencies at the time of purchase (i.e. reputedly good quality issuers), directly, through investment Funds and/or derivatives.

## Investment strategy

The Fund seeks to achieve capital growth by investing in the principal assets traded over the recommended investment period.

Within the limits imposed by the Fund's objective and investment policy, the management team makes discretionary investment choices in the portfolio based on its analyses of the characteristics and growth prospects of the assets traded.

The Fund may use derivative products both for investment and hedging purposes (hedging against unfavourable future financial events).

The Sub-Fund is not an index compartment and will be actively managed.

## Redemption of shares

On request, every day, in Luxembourg.

## Other information

This Class distributes income. Dividend distributions are planned.

The return of the product is determined by using the net asset value calculated by the Central administration. This return depends mainly on the market value fluctuations of the underlying investments.

The Sub-Fund's assets are seggregated from assets of other Sub-Funds of the Fund. The assets of the Sub-Fund cannot be used to pay debts of other Sub-Funds.

The recommended holding period of this product is determined to allow sufficient time for this product to reach its objectives and avoiding short term market fluctuations.

## INTENDED RETAIL INVESTORS

The product is suitable for retail investors with limited knowledge of the underlying financial instruments and no financial industry experience. The product is compatible with investors who may bear capital losses and who do not need capital guarantee. The product is compatible with clients looking for growing their capital and for receiving regular income and who wish to hold their investment over 2 years.

# **Risk indicator**





The risk indicator assumes you keep the product for 2 years.

# What are the costs?

## Costs over time

# Recommended Holding Period (RHP): 2 years.

The RHP was chosen to provide a consistent return less dependent on market fluctuations.

Redemptions are possible each bank business days in Luxembourg. All redemption requests must be received in good order by the Registrar and Transfer Agent prior to 12pm (Central European time) on three (3) bank business days preceding the applicable valuation date. Redemption proceeds shall be paid in the relevant Reference Currency usually one (1) bank business day following the applicable valuation date.
